1. **Permit Referral DR-1761:1001 N Rodney Street.** Request to remove most of the existing rear/side yard fence and introduce a driveway and parking pad in the rear yard of the house. **Cool Spring/Tilton Park City Historic District. Resolution 32-23.**

1. **Permit Referral DR-1763: 2205 Baynard Boulevard.** Request to create a driveway to run through the front yard to the rear property line. **Baynard Boulevard City Historic District. Resolution 34-23.**
