Summary of weekly exceedances (if any) and response actions:

- 1) A reading of 1.45 mg/m³ was reported at Air Station 4 at 7:35AM on 6/14/24 for 1 second in duration, which is less than the Action Level of 1.0 mg/m³ sustained for over 30 seconds. Therefore, no response action was required. No soil disturbing activities were occurring at the time.
- 2) Three short duration (18 seconds or less) readings above 1.0 mg/m³ were reported at Air Station 4 between 2:31-2:40PM on 6/19/24. None of the readings surpassed the Action Level of 1.0 mg/m³ sustained for over 30 seconds. The readings were determined to be attributed to activities assocaited with the demoltion of the gatehouse by the site contractor. Although no response action was required, the site contractor was contacted and asked to adjust dust suppression equipment during demoltion of the gatehouse.

Summary of photo-ionization detector (PID) readings for volatile organic compounds (VOCs):

1) A handheld PID was utilized by Verdantas and D'Huy Engineering personnel while onsite to monitor for VOCs during active soil disturbing activities. No sustained readings above 0 parts per million (ppm) were recorded, which is below the Action Level of 5ppm above ambient conditions, sustained for over 30 seconds. Therefore, no response actions were required.

General Comments and Observations:

1) Daily end times for monitoring correspond with the end time of daily onsite work by the site contractor.
