### **Required Plan Submittals**

Plans, specifications, and any other construction documents requested by the State Fire Marshal shall be submitted to the Office of State Fire Marshal for review and approval prior to any construction taking place for the following:

- 1. All new buildings and additions;
- 2. Any building undergoing a change in occupancy;
- 3. Any part of a building suffering damage from fire, explosion, or any other cause;
- For all dwelling units when attached in units of <u>three or more</u>, to verify the fire rated design of the required separation wall between units;
- 5. Tenant fit-outs;
- 6. Protective signaling systems;
- 7. All fire suppression and extinguishing systems;
- 8. Standpipe systems;
- 9. Fire pumps;
- 10. Water supplies and distribution systems for fire fighting purposes;
- 11. Emergency and exit lighting systems;
- 12. Egress/exiting systems (including but not limited to elevators and escalators);
- 13. Smoke removal and smoke control systems;
- 14. Fire lanes;
- 15. Flammable and combustible liquid installations:
- 16. Flammable gas installations; and
- 17. Other miscellaneous installations falling under the provisions of these Regulations.

Projects that do not require a plan submittal? Individual, detached, stand alone single family units and buildings used wholly for farming purposes do not require building plan submittals for review by the Office of State Fire Marshal.

# Requirements To Submit Plans

5-2008

### Step #1: Is your site plan drawn to scale and does it include the following information?

- 1. Name of the building or subdivision;
- 2. Plan date:
- 3. Full address:
- 4. Specific county's planning department reference number;
- 5. Owner's name and address:
- Design Professional's name and address;
- 7. Applicant's name and address;
- 8. Intended use of building or buildings;
- 9. Name of water supplier;
- 10. Location of all fire hydrants;
- 11. Location and diameter of all water mains supplying fire protection water;
- 12. Maximum height of the building;
- 13. Proposed building construction;
- 14. Whether or not proposed building(s) will be protected by automatic sprinklers;
- 15. Location of any fire lanes, their markings, and their widths; and
- 16. A plan note stating "All fire lanes, fire hydrants, and fire department connections shall be marked in accordance with the State Fire Prevention Regulations."

**Note:** When the plans include single family homes arranged in a townhouse or row house configuration, the following additional information shall be included:

- 1. A plan note stating how these townhouse or row house units are to be separated, and;
- 2. A cross section plan of a fire barrier wall indicating construction and fire rating, and;
- The above required fire barrier shall be listed by a testing laboratory meeting the requirements of Part I, Chapter 5 of the Delaware State Fire Prevention Regulations, and such information shall be included on the plan.

### **Step #2:** Do you have the following items ready for submittal?

- 1. Two (2) copies of your site plan;
- 2. Application for Fire Protection Plan Review; and
- 3. \$100.00 Site Plan Review Fee (check, money order, or cashier's check made payable to **City of Wilmington**)

### Stopping In

It is not a good idea to stop into the office or drop off plans if you want to talk to a Fire Protection Specialist, and, unless you call ahead and set-up an appointment, a staff member may not be available to be of service to you on this impromptu visit. We want to give you all the assistance and help that you need. We want to devote our full attention to your project and just "stopping-in" will be a distraction from another client's project. Support Staff will assist you with submission of your plans, but will not be able to answer technical questions.
