

## Ethics Commission Meeting Minutes Louis L. Redding City/County Building 800 N. French Street 5<sup>th</sup> Floor Atrium Conference Room Wilmington, DE 19801

Meeting was called to order by Mr. Johnston, Chair, at 4:08 p.m. The following people attended:

The Commission will meet November 19; The Futures Committee will change their November date to same If needed. The remaining dates for the year are 10/08, 11/19, and 12/10. Dates for the first quarter of 2020 include 1/14, 2/11 and 3/10.

At 4:27 pm, Mr. Toliver moved and Ms. Meisinger-Petit seconded to go into executive session.

It was properly moved by Mr. Toliver and seconded by Ms. Meisinger-Petit at 4:36 pm, to end the executive session and move the meeting back to public session.

Mr. Larson reported that the Mayor's Office is working on appointments to fill the appointments now occupied by Mr. Hatch and Mr. Hawkins.
